Web sites that collect personally identifiable information should provide individuals with clear and conspicuous notice of their information practices at the time of infor-mation collection. Individuals should be notified as to what type of information is collected about them, how the information will be used, and whether the informa-tion will be transferred to unrelated third parties. Because H. R. 4678 requires data collectors who sell customer PII to post notice at the time of data collection, consumers will know that the collectors practices may raise an issue of consumer privacy, and allows them to find out exactly what those practices are. Con-sumers should have the opportunity to opt out of the use or disclosure of their per-sonally identifiable information for purposes that are unrelated to the purpose for which it was originally collected. Consumers should be allowed to receive benefits and services from vendors in exchange for the use of information. It is important that the consumer understands this use and is able to make an informed choice to provide information in return for the benefit received. H.
